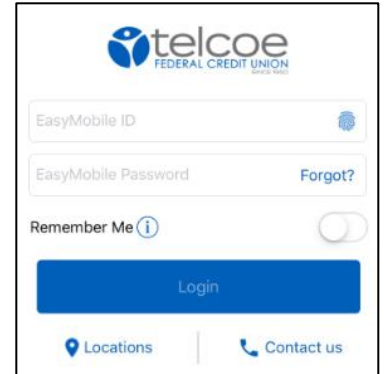

Individual Retirement Accounts allow you to save for specific retirement goals and provide long-term tax advantaged savings.

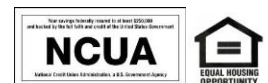
